1 On May 2, 2018, the Court entered a Corrected Order Granting Plaintiffs' Motion for Final
2 Approval of Proposed Amended Class Action Settlement ("Corrected Order"). Pursuant to
3 paragraph 13 of the Corrected Order, the date for the Class Notice Administrator to mail the
4 allocation/distribution letters to Settlement Class Members pursuant to Paragraph 8 of the Amended
5 Plan of Allocation and Distribution is June 16, 2018.

6 **WHEREAS**, the parties and their counsel, working with the experts retained by the Class
7 and the Class Notice Administrator, have determined that additional time is needed to prepare and
8 finalize the allocation/distribution letters;

9 **WHEREAS**, class counsel anticipates that the allocation/distribution letters will be finalized
10 for mailing by July 20, 2018;

11 **WHEREAS**, the parties believe that no other dates set by Court order currently need to be
12 revised if the allocation/distribution letters are mailed on July 20, 2018, rather than June 16, 2018;

13 **THEREFORE**, the parties stipulate that the date to mail the allocation/distribution letters
14 shall be continued from June 16, 2018, to July 20, 2018.
