**ORDER RE: POSTCARD NOTICE
REGARDING VACATED CLASS
ACTION DEADLINES AND HEARING
DATE**

Pursuant to the Court's June 8, 2017 Order Vacating Dates and Deadlines Contained in Preliminary Approval Order and Setting Case Management Conference, the Court hereby approves the following language for the postcard notice, which Rust Consulting, the Court-appointed class notice administrator, shall send by first class mail to all class members as soon as reasonably practicable:

3 **NOTICE THAT CLASS ACTION DEADLINES AND HEARING DATE**
4 **HAVE BEEN VACATED AND WILL BE RESCHEDULED**

5 You are receiving this Notice because records indicate that you are a member of
6 the proposed class in the above-referenced case. A Notice describing the
7 proposed settlement and setting forth deadlines for objections and opting out of
8 the settlement was previously mailed to you on May 11, 2017. As explained
9 below, the deadlines in that Notice have now been vacated and will be
10 rescheduled. A separate notice of the rescheduled dates will be mailed to you as
11 soon as they are determined.


12 After the Court preliminarily approved the proposed class action settlement, the
13 parties in the above-referenced case, including California Dental Association and
14 Delta Dental of California, discovered a miscalculation of the financial impact of
15 the "INAP" limitation on fees of Premier dentists. This miscalculation could
16 impact the Proposed Settlement. The Court therefore determined that all
17 previously set dates in the May 11, 2017 Notice, including the deadline for
18 submitting objections and opt-out requests and the date for the Final Approval
19 Hearing, should be vacated and rescheduled so the parties may investigate and
20 determine the extent to which this newly-discovered information affects the
21 terms of the proposed settlement. The Court has also ordered the parties to
22 complete this process and report the results of their investigation at a Case
23 Management Conference on August 25, 2017. You are not required to attend
24 this conference.


